FAY SASSER MAC EMPLOYEE SCHOLARSHIP PROGRAM

This scholarship program was created in recognition of Fay Sasser's 44 years of exceptional and dedicated service to the members of the Multnomah Athletic Club. The MAC Board of Trustees and the club membership established the scholarship in 1997. It is managed by the Multnomah Athletic Foundation. The mission is to fund higher education for student's accredited degree completion. Based on availability of funding, current high school students may apply while taking core college classes.

ELIGIBILITY REQUIREMENTS

In order to be eligible for this scholarship, applicants must be:

- a high school student, high school graduate or GED equivalent or college student; and
- a current MAC employee with a minimum of two year of consecutive service; and
- hold a position other than senior management; and
- eligible for MAC employee athletic facilities use (working approx. 10 hours a pay period); or
- a descendant (natural, step or legally adopted) of a current MAC employee as described above.

2019 APPLICATION REQUIREMENT

Complete application packets must be received **no later than May 1, 2019**. Please obtain your transcripts and send them with your application packets. No items should be sent individually or directly to the club. Only completed packets will be considered for the Fay Sasser MAC Employee Scholarship Program.

The following items must be in a completed application packet for consideration:

- **Application** – the form must be typed.
- **Free Application for Federal Student Aid (FAFSA)** – Summary page with Expected Family/Individual Contributions
- **Two letters of recommendations** – Letters should be from adults who are acquainted with you. These may be teachers, counselors, employers or other community members who are non-relatives.
- **Transcripts**
 - High School:** Graduating high school seniors or high school graduates who have never attended college students should send transcripts that show courses, grades, cumulative GPA through the seventh high school semester.
 - GED:** Certificate recipients who have never attended college should send a Transcript of GED record.
 - College:** Continuing college students should send a transcript for each institution where undergraduate or graduate course work was completed through January 1, 2019.

SELECTION PROCESS

The application will be available March 5, 2019 and the deadline for completed application packets is May 1, 2019. The selection committee will evaluate the packets and conduct interviews in May/June. The scholarship recipients will be announced in early June.
