

SCHOLARSHIP DEFERMENT

Effective May 2020 and in response to COVID-19, the Multnomah Athletic Foundation has implemented a scholarship deferment program as a way to be responsive to the needs and wellbeing of our scholarship recipients. The foundation's deferment practice will be reviewed annually to determine if is still the best solution and relevant the needs of the foundation and its students.

Students who have been a scholarship may defer funding under certain circumstances. The student must meet the criteria of their designated award and be in good standing with the foundation at the time of deferment. The intent is to support students pursuing post-secondary education and to provide flexibility in their journey.

Deferment Timeframe and Submission Information:

Scholarship deferment requests must be completed and submitted to info@multnomahathleticfoundation.com by January 1st or August 1st of the respective year in order to be eligible. Do not assume we have received your documents until you receive a confirmation email from the foundation.

Scholarships can be deferred for either a minimum of 6 months or up to 12 months. You may choose on 12-month deferment or defer up to 2 consecutive periods of 6 months.

The exception to the above stated timeframe is the MAC Scholar Athlete program which can be deferred for up to 6 years from high school graduation upon a year by year deferral basis. If your plans change and you wish to end your deferment early, please contact the foundation at info@MultnomahAthleticFoundation.com, requests will be considered on a case by case basis.

Student Expectations for Funding Requests:

As a courtesy the Multnomah Athletic Foundation will communicate upcoming deadlines to scholarship recipients to encourage the utilization of the funding. It is the student's responsibility to submit the Authorization for Funding form and supporting documentation in order to initiate a new funding request. If the funding request documentation is not completed and submitted by the end of your deferment term, the scholarship funding obligation is terminated.

Funding requests for the spring term need to be completed by January I^{st} of the respective year, funding request for the fall term need to be completed by August I^{st} of the respective year.
